- 1.2. The clarifications and amendments appearing below replace and supersede all prior correspondence, whether written or oral, and shall constitute the sole binding document with respect to the subject matter hereof and an integral part of the Tender Documents.
- 1.3. Except where expressly stated hereafter, nothing in this clarification and amendment letter shall be construed to derogate from the Tender Documents.
- 1.4. **Bidders are requested to send a confirmed signed copy of this Clarification & Amendment no. 2, as well to submit them signed as integral part of their Bid.**

1	Q	ITB, doc. no. 397389, Sections 12.2.11, 12.2.12	What does INGL means with "original printed contract/tender documents"? Does it refer to the specifications we have received by e-mail or to the hard copy we have received by currier?
	A		The original hard copy booklet of the Tender documents (including the ITB & the Contract) and the Tender original CD provided to the Bidders by courier shall be submitted by the Bidder in Envelope 1 of the Bid, according to the Tender's instructions. Please note there is no need to submit the Specifications included in the Tender CD. However the updated Specification EEN-EPI-SPC-022 Ball Valves ≥ DN 100 (4")

			Revision 6 attached to Clarification & amendment no. 1 dated 27/05/2019) shall be initialled by the Bidder and submitted in Envelope 1 of the Bid.
2	Q	ITB, doc. no. 397389, Sections 12.2.14, 12.3.7	It is not clear how may CD we shall prepare for each envelope. As far as we understand we have to prepare a CD for Envelope 1 + Envelope 2. No indication had been given for Envelope 3.
	A		The content of each of the Envelopes 1 & 2 of the Bid shall be colored scanned to separate CDs and be included in the relevant envelopes, as described in sections 12.2.14 & 12.3.7 of the ITB. Envelope 3 of the Bid which includes the Quotation shall not be scanned to a CD.
3	Q	ITB, doc. no. 397389, Section 15	We understand the prices shall be valid for 9 months and that indexation mechanism (the attached annex 8 to the Contract doc. no. 397384) shall apply in order to re-calculate prices. However, please explain how it works as the paragraph doesn't give a clear explanation.
	A		<p>Please see Section 15.3 of the ITB which refers to Clause 15.2 of the Contract. Clause 15.2 of the Contract together with Annex 8 of the Contract explains if, when and how the indexation mechanism shall be applied.</p> <p>Please note that the Quotations (the price proposal) in this <u>specific Tender</u> are valid for 9 months as of the Last Submission Deadline (as such date was updated in Clarification & Amendment no.1). However please note that subject to the Company's discretion in accordance to the Tender it is the Company's intention to issue a Purchase Order to the successful Bidder without delay after his selection by the Company.</p>

3. **Amendments**

3.1. **Specification**

In the updated Specification EEN-EPI-SPC-022 Ball Valves \geq DN 100 (4") Revision 6 (attached to Clarification & amendment no. 1 dated 27/05/2019) the following corrections shall apply:

In Section 17.1.2, Table A1, Column "Nominal wall thickness (mm)", the wall thickness of the following Pipe Sizes shall be as follows:

8" – 12" 10.3 mm, 30" 17.5 mm, 36" 17.8 mm.

The Material Grades and Nominal wall thicknesses shall be according to Specification ENG-X17-SPC-0019 latest revision (currently Rev. 4 dated 14/09/17), attached to the Tender Documents.


3.2. Quotation Price Form

In the Updated Annex A16 - Quotation price Form dated 23/05/2019 (doc. no. 404019) of the Tender (attached to Clarification & Amendment no. 1 dated 27/05/2019) the following typos shall be corrected:

- a) Notes no. 1, 3 (Page no. 2) – the correct version of Specification EEN-EPI-SPC-022 is **Rev. 6** (and not rev. 5).
- b) Note no. 6 shall be read as follows (the corrections are underlined and strikethrough for convenience only):

"Each welded Ball Valve shall be equipped with welding pups. The material grade and minimal wall thickness of the pups shall be as specified in item **17** [~~26-16~~] of EEN-EPI-SPC-022 REV **6** [~~5~~]."

The Bidders are requested to acknowledge receipt of this **Clarifications & Amendment No. 2** by returning an executed copy of the attached acknowledgment receipt form.
