

# **Public Tender for the Supply of Fittings**

Israel Natural Gas Lines Ltd. (the "**Company**"), an Israeli governmental owned company, hereby invites manufacturers and/or suppliers of fittings ("**Fittings**") to submit bids in order to be qualified as an approved suppliers in the Company's list of approved suppliers from which the Company may order the supply of Fittings ("**Tender**").

The list of the approved suppliers shall be valid for 5 years and the Company may extend such period for an additional period of 2 years.

## **Threshold Requirements**

## (A) Bidder's Structure

The Bidder must be one legal entity duly organized and validly existing under the laws of the jurisdiction in which it was organized and shall not be either a joint venture or consortium or an unregistered partnership.

# (B) Qualifications & Capabilities

The Bidder:

- 1. Has in place a management system that is certified as ISO 9001 compliant or a management system that meets the ISO 9001 certification requirements.
- 2. The Bidder operates an "in- house" quality control department for the Fittings supplied.
- 3. **If the Bidder is a manufacturer of Fittings** The Bidder manufacturing standards shall fully conform or not contradict the NEN3650 Dutch standard, and with all of the requirements and specifications set forth in the technical Tender Documents.

# (C) Professional Experience

- 1. The Bidder is a manufacturer or a supplier of Fittings at least since January 1st, 2014.
- 2. If the Bidder is **not a manufacturer** of Fittings it holds and operates by itself a warehouse for Fittings in the area of at least 5,000 square meters located in a High Income OECD Country.
- 3. The Bidder supplied, during the period as of January 1, 2014 until the Last Submission Deadline (the "**Presented Period**"), Fittings meeting **all** the following criteria:
  - 3.1. were designed for pressure of at least 70 bar and of at least 4 inches diameter, and
  - 3.2. were manufactured in a High Income OECD Country.
  - 3.3. were supplied (including indirectly), for the use in a natural gas transmission system or project.
  - 3.4. generated the Bidder a turnover of:
    - 3.4.1. at least €5,000,000 for the entire Presented Period; and
    - 3.4.2. at least  $\in$  1,000,000 in average for 3 years out of the years 2015 2019; and
    - 3.4.3. the supply during the Presented Period included at least 3 orders of Fittings of at least €200,000 per order.
  - 3.5. the Fittings supplied during the Presented Period included at least 10 items of Tees equal to or greater than 30 inch diameter (in total; does not required per a specific order).

For compliance with the above **Qualifications & Capabilities and Professional Experience above**, **a Bidder may rely upon its Affiliate** (as such term is defined in the Tender).

# **(D)** Financial Requirements

The Bidder's **last** audited financial statements does not include a "Going Concern" notice.

#### (E) General Requirements

- 1. The Bidder is not listed as an entity whose activity in Israel and the economic activity of Israeli entities with are limited or prohibited.
- 2. Israeli Bidder shall hold and submit all the approvals required pursuant to the Law of Transactions of Public Entities, 1976.

## **Quality Evaluation**

Obtaining a Quality Score of at least 75 points and at least 50% points allocated for each main category examined in the Quality evaluation, is a precondition for qualification.

#### **General Information**
