1.0 **INTRODUCTION**

1.1 **Israel Natural Gas Lines Company Ltd. (“INGL” or “Company”)**

- a) INGL is a company which was established in 2004; operates under the auspices and regulation of the Israeli Natural Gas Authority, in accordance with the Israeli Natural Gas Market Law, 2002 (the "**Natural Gas Law**"); is fully owned by the Government of the State of Israel, and is authorized, licensed (until 31.7.2034) and responsible for erecting and operating the Israeli natural gas transmission system (the "**System**").
- b) The System constructed and operated by the Company includes, inter-alia, approximately 800km onshore and offshore transmission pipelines throughout the State of Israel, 3 receiving terminals from different gas fields, one LNG FSRU STL Buoy, about 50 pressure regulating and metering stations (PRMSs) transmitting the gas to Israeli clients and distribution systems, and 3 border terminals exporting gas to Egypt and Jordan, one of them includes a compressor station (operated by the exporter).
- c) As of June 2018, part of INGL's bonds is traded in the Israeli Stock Exchange.
- d) More about the Company can be viewed at its website: www.ingl.co.il.

1.2 **The UGS Projects and Zohar Field**

- a) INGL considers developing underground storages ("**UGS**") of natural gas for operational and strategic purposes including the "Zohar" field located about 50 km southeast of Be'er Sheva and 10 km west of the Dead Sea graben ("**UGS Projects**" and "**Zohar Field**").
- b) Over the years the Zohar Field had been studied in various reports and recently by RPSgroup in a report attached as **Annex 11.2** to this ITB ("**RPS Report**").
- c) INGL would like to: 1) prepare a detailed appraisal plan for further investigating the capacities and performance of Zohar Field including but not limited to by checking and validating the RPS Report and performing a 3D geological modelling of the Zohar Field; 2) execute the appraisal plan including by executing exploration drillings; 3) based on the outcomes – prepare a development plan and technical-economic evaluation for the Zohar Field; 4) review other possible alternatives for UGS Projects in Israel, discuss their suitability also for storing Hydrogen (H₂) and Carbon Di-Oxide (CO₂) and compare between all the options including Zohar Field itself. At a later stage and based on such study outcomes (granted that the results of the study enable to do so), an engineering design shall be prepared, and an underground storage will be constructed and operated.

1.3 **The ITB Goals**

This ITB process is aimed to select a Bidder to provide INGL consultancy, engineering, and supervision services (as owner's engineer) regarding UGS Projects according to the Scope of Work attached as **Annex 4**.

1.4 Invitation to Bid ("ITB")

- a) The Company invites Bidders to submit Bids for the provision of Services in accordance with these ITB Documents which shall direct Bidders with respect to all aspects of the preparation of their Bids.
- b) Invitation of a Bidder to submit a Bid shall not be construed in any way as the Company's acknowledgment that the Bidder is qualified or as to the quality of its Bid, if submitted.

1.5 Definitions

All following terms in this Tender shall have the meaning ascribed thereto below:

Affiliate - in relation to any company, at any time, any other entity:

- a) In which such company directly or indirectly controls more than 50% of the registered share capital or rights to vote; or
- b) Which directly or indirectly controls more than 50% of the registered share capital or rights to vote of such company; or
- c) Of which an entity in the above-mentioned Clause b) controls directly or indirectly more than 50% of the registered share capital or rights to vote.

Bid – A proposal submitted by a Bidder according to the terms of the ITB Documents.

Bidder – The entity submitting a Bid to the ITB.

Company or **INGL** - Israel Natural Gas Lines Company Ltd.

Connected Party means interested party in a corporation, as such term is defined in the Securities Law, 5728-1968.

Consultant – The Bidder that shall be declared by the Company as the successful Bidder in this Tender for the provision of the Services.

Contract/Agreement – The document of the Contract for the provision of the Services attached as **Annex 6** and all attachments and annexes thereto, that will be signed between the Company and the Consultant.

Day – a calendar day according to the Gregorian calendar.

Deviation – Any unauthorized change, omission, reservation, condition and/or addition made by the Bidder to the ITB Documents, in any way, manner and/or scope (including in the Bid itself).

High Income OECD Country - As defined by the world bank (<https://data.worldbank.org/?locations=XD-OE-XT>).

Services – Consultancy services and ancillary matters related services, all according to the Scope of Work attached as **Annex 4** and the ITB.

Project Manager – Shall mean the designated representative of the Consultant, managing the Services rendered to the Company, as approved by the Company.

Submission Date - The deadline listed herein for submitting the Bids.

ITB or Tender – The invitation to bid issued by the Company in relation to the Services.

ITB Documents - The documents according to which the Bidder is required to submit its Bid, including: this Invitation to Bid, the Contract and all annexes and attachments to such documents.

ITB Prices – The prices quoted for the Services to be provided by the Bidder in the form attached as **Annex 3** herein.

Laws - all laws and regulations of the State of Israel.

Scope of Work – The scope of work required by the Company for the provision of the Services in accordance with the Contract, as detailed in **Annex 4**. All the tasks set in the Scope of Work given by the Consultant, may be referred also as the "**Project**".

1.6 In the ITB Documents, unless the context requires otherwise:

- a) Headings are for convenience only and do not affect interpretation.
- b) Words in the singular include the plural and vice versa.
- c) A reference to “includes” or “including” means “includes, without limitation” or “including, without limitation”, respectively.
- d) A reference to a right or determination, to be made or act, decide or not, by the Company, means, the sole and absolute discretion of the Company.

1.7 **Regulating Authorities**

The construction and operation of the System are under the regulation and supervision of the Israeli Natural Gas Authority ("**NGA**") that has the right to always inspect and overlook all aspects of the System, in accordance with the Israeli Natural Gas Laws.

1.8 **Costs of ITB & Disclaimer**

The Bidder shall bear all costs, directly and indirectly, associated with the preparation, delivery and submitting of its Bid (including, if necessary, site visits, provision of additional documentation, rectified bid, renewed Bid, attendance in meetings and presentations, etc.). The Company will in no case be responsible or liable for any costs and/or damages related to the above mentioned and/or due to exercising any of the Company's general prerogatives. By submission of its Bid the Bidder waives all claims against the Company in respect to the above mentioned and the ITB.

1.9 Insurances

The Successful Bidder will be required to arrange and maintain Insurance policies at its own expense, as stipulated in the Agreement.

The Company may, at its sole discretion, alter the dates and deadlines set forth in this Section 1.10 or anywhere else in the ITB Documents.

1.11 Prohibition of Coordination of Bids, Submission of Mutual Bids & Conflict of Interest

- a) Bids shall not be jointly submitted by few Bidders / corporations / entities, etc. The Bidder shall be one legal entity and shall not be either a joint venture/consortium or an unregistered partnership.
- b) Bidder or Bidder's Connected Party and/or anyone acting on their behalf shall not coordinate a Bid with other Bidder or with other Bidder's Connected Party and/or with anyone acting on their behalf and shall not be in a status of concern of conflict of interest prohibited by the Laws, with INGL, and shall inform INGL in writing regarding any possibility for the existence of the abovementioned concern. In this clause, "**Coordination of a Bid**": Including through agreements, settlements, understandings of any kind, expressed or implied, in relation to a matter relating to the ITB process, the ITB Prices, the terms of the Agreement and strategies for pricing, delivery and/or exchanging and/or receipt of information in relation to the ITB process or disclosure of such information in other way, among Bidders, Bidders' Connected Parties or anyone acting on their behalf.
- c) Only one Bidder among Bidders connected in any manner (e.g., single Bidder and a company owned by such Bidder, parent company and its subsidiary, etc.) - shall be entitled to participate in the ITB process.
- d) Bidder shall include in its Bid, a statement declaring if any of its managers and/or employees have any family relation to any of INGL's managers and/or employees, solely based on its knowledge and without being requested to execute an inquiry in relation hereof. The statement shall be attached in a separate letter to the Bid and shall be signed by Bidder's owner / CEO / authorized signatories.

1.12 General Prerogatives of the Company

Notwithstanding any other provision herein, and without derogating from the Company's rights in these ITB documents, the Company may, at its sole and absolute discretion, do any of the following, at any time including after the Final Submission Date and, in the framework of negotiations:

- a) Decide not to enter the Contract with the successful Bidder.
- b) Cancel the ITB for whatever reason (including related solely to the Company).
- c) Amend or waive any of the terms of the ITB Documents. In which case the amendment will apply equally to all the Bidders, and they will all be given the opportunity to resubmit their Bids or any part thereof, all in accordance with the written instructions of the Company.
- d) Find a Bid unsuitable, or to disqualify Bids that are not fully compliant with the ITB Documents or due to a minor default or lack of information. In such event the Company may request the Bidder to rectify the default, and/or provide any necessary information and/or clarifications even where the Final Submission Date has passed.
- e) Request additional information and/or clarifications and/or documents and/or by way of demonstration of the Bid in the Company from any of the Bidders, including by conducting independent inquiry regarding any matter connected with the ITB, the Bidder and its Bid, or conditionally pass any Bidder with respect to any of the requirements of the ITB Documents subject to the receipt of any of the above prior to awarding him the Contract.
- f) Award the Contract to the Bidder whose Bid placed second in the evaluation process (and so forth in the same manner) in the event of the cancellation of the award of the Contract as a result of the failure of the Bidder chosen by the Company to meet all requirements of the Contract. This provision shall also be applicable to such Bidder.
- g) Provided that the Company first afford the affected Bidder an opportunity to present arguments in support of its Bid, disqualify any Bid with respect to which the Company concludes, at its sole discretion, that the information supplied in the Bid, including the proposed personnel, do not accurately reflect the actual ability of the Bidder to execute the Services for any reason whatsoever, and without limitation, to require such Bidder to replace such proposed personnel with such newly skilled personnel within the time decided by the Company and subject to its prior approval.
- h) At every stage of the Tender, including at the stage of deciding whether to open and review the Bidder's Bid, the Company may, in its sole and absolute discretion, consider any information relating to the Bidder and/or the content of the Bid. To the Company's knowledge in any other way, which may affect, at the sole discretion of the Company, the Bidder's participation in the Tender or its selection as a winner or its ability to provide the Services.

1.13 Governing Law & Jurisdiction

The ITB shall be governed by and construed in accordance with the applicable Laws. In any event of any unsettled dispute the authorized courts of the city of Tel Aviv - Jaffa shall have the exclusive jurisdiction.

2.0 **THE ITB DOCUMENTS**

- a) The Bidder shall examine the ITB Documents contained therein. Failure to furnish the information required by the ITB Documents or submission of a Bid not substantially responsive to the ITB Documents in every respect may result in the disqualification of the Bid.
- b) The Bidder shall carry out its own independent research and inquiries about all aspects of the Services, including, but not limited to planning, designing, commercial and legal requirements and all other relevant information relating to any aspect of the Services that may be necessary or useful for the preparation of the Bid.
- c) Whilst this ITB has been prepared with due care, any information contained herein is indicative only and it is provided in good faith for the guidance of the Bidder. No representation, warranty or undertaking, expressed or implied, is or will be made, and the Company and anyone acting on its behalf shall not have any responsibility or liability, and in this respect section 1.6 above shall apply.
- d) Each Bidder, by submitting a Bid, shall be deemed to acknowledge that it is acquainted with and has agreed to all ITB Documents, and all instructions, conditions, and provisions of the ITB, the Bidder shall conduct the necessary analysis and evaluation to ascertain the correctness, completeness, and sufficiency of its Bid for the supply of Services and the prices stated in its Bid before submitting its Bid. The prices proposed in the Bid shall cover all the Bidder's obligations and all matters necessary for the completion of the Services.
- e) The Bidder acknowledges that if it determines that the ITB Documents are not detailed enough or are in any way inadequate, it is required to notify the Company, by means of issuing a request for clarification to the Company in accordance with Section 2.2.
- f) The ITB Documents are available online on the Company's Website www.ingl.co.il. Until the Last Submission Date Bidders are required and recommended to enter the Tender portal at the Company's Website (www.ingl.co.il) (under "Tenders/Publication" tab) daily and check for updates and information issued by the Company.
- g) Prior to and as a precondition to receiving Annexes 11.1-11.3 from the Company, Bidders shall send their contact details and obligation of confidentiality in the form attached as **Annex A2** via e-mail to the Company at the contact information set forth in Section 2.2 below.

2.1 **Conflicts between ITB Documents**

In the event of conflict between any provisions of the ITB Documents, the order of precedence set forth in clause 2.3 of the Contract shall prevail.

2.2 Clarification of ITB Documents

- a) Prospective Bidders requiring any further information or clarification of the ITB Documents and the ITB process may notify the Company via e-mail, at the e-mailing address indicated below by no later than the date specified in clause 1.11 above. The request for clarification will be made in a "Word" file table and specifically refer to the relevant clause in the ITB or in the Agreement, as applicable. Bidders are recommended to take measures to make sure such request for clarification is received by the Company.

- b) The decision to respond to requests for clarification received will be at the sole discretion of the Company. The Company's response on any substantive issue/interpretation (including an explanation to the query) will be sent by e-mail, to all prospective Bidders who have received the ITB Documents. The Company's written response shall constitute an integral part hereof. The Company shall neither be considered nor be liable for any response or information not delivered by the above representative.
- c) The Bidders will be required to acknowledge in writing receipt of any such response to a request for clarification; provided, however, such response shall be effective as an integral part of the ITB Documents whether the Bidders so acknowledge receipt of the response or not.
- d) No Company response shall be binding unless it is issued by written addenda as part of the Tender process and sent to the Bidders and/or published in the Tender portal at the Company's Website.

2.3 Amendment of ITB Documents

At any time prior to the deadline for submission of Bids, the Company may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the ITB Documents and/or any of its conditions by amendment.

2.4 Severability

Any part, provision, or section of the ITB Documents being found to be invalid or unenforceable, shall not affect the validity or enforceability of any other part, provision, or section. Such invalid or unenforceable part, provision or section shall be deemed severed from the ITB Documents which shall be construed and enforced without reference to such part, provision, or section.

2.5 Proprietary Rights

- a) All ITB documents including its annexes and all subsequent work products including, without limitation plans, designs, and drawing, submitted to the Company by the Bidder and its sub-contractors, or Intellectual property rights developed in the process of executing the Services of this ITB, shall be the absolute property of the Company.
- b) The Bidder waives any and all property rights of any kind whatsoever in the work product of the Services in favour of Company and, it will have no objection and it agrees that the Company will make such use as it deems fit of the work and/or material that is submitted to it in the scope of the Services, including submitting the whole and/or parts of it to entities and/or authorities and/or individuals, as it deems. The Bidder shall be entitled to use the above for the purpose of this ITB only, and shall return all documents, including copies if made, to the Company with the Company's order or in completion of the Services, at the earliest.
- c) The Bidder shall specifically note and mark in its Bid any kind of data or information which the Bidder has any Intellectual property right, and the Company shall treat it as such.

3.0 THRESHOLD REQUIRMENTS

In order to participate in the Tender process, Bidders must meet all of the following prequalification (the "**Threshold Requirements**"):

3.1 The Bidder's Structure

- a) The Bidder must be an entity duly organized and validly existing under the laws of the jurisdiction in which it was organized.
- b) The Bidder itself must comply with the Threshold Requirements, unless explicitly stated otherwise in the Tender.
- c) The Bidder shall be one legal entity and shall not be either a Joint Venture or Consortium or an unregistered partnership.

3.2 Professional Experience of the Bidder

The Bidder comply with all the following requirments:

- a) The Bidder has been providing engineering consulting services in reviewing and characterization of Natural Gas reservoirs projects since at least the year 2012.
- b) During the period as of 2015 the Bidder provided to Natural Gas transmission systems operators and/or Natural Gas producers, located in a current High-Income OECD Country (as defined in Clause 1.5 above), planning services and owner's engineer consultancy for at least 2 UGS Natural Gas projects, at least 1 of which was in a depleted reservoir.

To this end each project had been activated until the Last Submission Date.

- c) The Bidder holds an in-house capability to perform Three-dimensional geological modelling of Natural Gas reservoirs.
- d) The Bidder employs at least 15 employees.

For the purpose of meeting the conditions specified in this Clause 3.2 above and Clause 5.1(b) below, a Bidder may rely upon the professional experience gained and accumulated by a legal entity from which the Bidder purchased and/or acquired and/or received activities and assets, including by way of a merger under the laws of the jurisdiction in which the Bidder was incorporated, as well as by any kind of a transaction of assets/activities (hereinafter: "**Acquired Corporation**").

3.3 Team Members

The Bidder proposed in its Bid all the following personnel for the provision of the Services, meeting the requirements specified below:

- a) 1 Senior Executive Engineer
 - (i) With at least 15 years of professional experience in Natural Gas UGS projects such as: conducting and/or supervising over feasibility studies and natural gas UGS projects, natural gas UGS project managing, experience with natural gas UGS in salt formations and in aquifer reservoirs, supervision of exploration drillings, writing of specifications, reviewing tendering and procurements processes.
 - (ii) Provided planning services and owner's engineer consultancy in UGS Natural Gas projects at least since 2017.
 - (iii) Had been involved in at least one technical study of UGS for Hydrogen or CO₂.
 - (iv) Bidder or its Affiliate employee in the rank of technical/engineering executive in the Bidder.
 - (v) Fluent in the English language.
- b) 1 Engineer
 - (i) With at least 10 years of professional experience in the development of Natural Gas UGS projects including the planning of the sub-surface facilities of such projects.
 - (ii) Had been involved in at least one technical study of UGS for Hydrogen or CO₂.
 - (iii) Bidder or its Affiliate employee or a freelance or a sub-contractor.
 - (iv) Fluent in the English language.

- c) 1 Engineer
- (i) With at least 10 years of professional experience in the development of Natural Gas UGS projects including the planning of the **surface** facilities of such projects.
 - (ii) Bidder or its Affiliate employee or a freelance or a sub-contractor.
 - (iii) Fluent in the English language.

3.4 General Requirements

- a) The Bidder is not listed as an entity whose activity in Israel and the economic activity of Israeli entities with it are limited or prohibited by the Act for Fighting Iran's Nuclear Plan, 2011 or the Act for the Prevention of the Distribution and Financing of Weapons of Mass Destruction, 2018.
- b) If the Bidder is an Israeli Bidder or an Israeli resident (as defined in the Israeli Income Tax Act), it shall hold and submit all the approvals required pursuant to the Law of Transactions of Public Entities, 1976 and a duly executed affidavit in the form attached as **Annex 10**.

Only Bidders who comply with all the aforesaid Threshold Requirements shall be entitled to participate in the Tender process.

4.0 PREPARATION and SUBMISSION OF BIDS

4.1 Compliant Bids

- a) Bidders are required to submit Bids that comply with the financial, legal and technical requirements contained in the ITB Documents including, without limitation, Section 3.0 hereof (hereinafter "**Compliant Bids**").
- b) Bidders may not deviate in their Bid from the instructions of the Tender and Agreement unless prior permission has been specifically granted in writing by the Company in accordance with clause 2.2 above. The Company may disqualify any Bid containing any such Deviation/s or demand that the Bidder amend its Bid.
- c) The submission of a price quotation in the Bidder's E-MAIL 2 shall be construed as evidence that the Bidder has provided a firm offer which cannot be retracted by the Bidder. The Bidder may not submit a conditional Bid. Any statement to the contrary shall be null and void.

4.7 Language

5.0 SUBMISSION OF BIDS

6.0 THE ITB EVALUATION PROCESS

6.1 Prerequisites & Evaluation Criteria

The Company will evaluate the various Bids that it receives in accordance with the following two stage process:

- a) **STAGE 1** - Review of general requirements and Threshold Requirements compliance:

The Company will review whether E-MAIL 1 includes all the documents listed in Section 4.3 (a) above to determine whether a Bidder meets the general requirements and the Threshold Requirements as provided in Clause 3.0 above for Bids to be considered by the Company. Bids which shall include all the aforementioned documents and comply with the Threshold Requirements will successfully pass Stage 1.

A Bidder that falls short of meeting any of the Threshold Requirements in accordance with Company's discretion will not progress to the next stage of the ITB.

At any stage the Company shall be entitled, based on the information provided by the Bidder in the form of **Annex 9(1)** herein, and at its sole discretion: (i) to request the Bidder to provide further information; (ii) to disqualify any Bidder that has a connection with an entity which competes or may compete with the Company or is or may become the Company's client or connected to the Company in any manner which might create conflict of interest; (iii) to determine other means or conditions for continuing the participation of the Bidder in the ITB.

- b) **STAGE 2** - With respect to those Bidders that successfully passed Stage 1, the Company will rate and grade the Bid's quality (the "**Quality Score**").

The Bids shall be evaluated and scored according to the following criteria and stages:

Written proposal - up to 50 points, as follows:

- (b) The proposed Methodology and its compliance with the Scope of Work – **up to 15 points.**
- (c) Relevant Experience of the Bidder's Senior Executive Engineer, according to the form attached as **Annex 5(1)** and provided CV according to the following criteria:
- i. Number of natural gas UGS projects.
 - ii. The above natural gas UGS projects status and complexity.
 - iii. Senior Executive Engineer's involvement in the above natural gas UGS projects.
 - iv. Senior Executive Engineer's level of involvement in Hydrogen and CO₂ underground storage studies.
- up to 10 points.**
- (d) Relevant Experience of the Bidder's other Team Members according to the forms attached as **Annex 5(1)** and provided CV according to the following criteria:
- i. Number of natural gas UGS projects.
 - ii. The above natural gas UGS projects status and complexity.
 - iii. Team Member's involvement in the above natural gas UGS projects.
 - iv. Level of involvement in Hydrogen and CO₂ underground storage studies
- up to 8 points each to a maximum of 16 points.**

The allocation of the above scores will be based on the Bidders' written proposals.

- c) **STAGE 3** - The 4 best ranked Bidders (which had been awarded by the Company the top Quality Scores based on the Bidders' written proposals) will be invited to present before the Company the Team Members and proposed Methodology for the Project as provided below. The rest of the Bidders shall not continue to the next stages.

Presentation to the Company and Interview – up to 30 points, as follows:

- (a) Presentation of the proposed methodology related to the Scope of Work – **up to 15 points.**

Bid's Price Score – up to 20 points

Calculation of the Bid's Price Score

- (a) The lowest Bid's Price (comprised of the Total Fixed Fee, Total Daily Fee and Total Hourly Fee) (the "**Lowest Bid Price**") shall be granted the full score 30 points.
- (b) The rest of the Bids shall receive a relative score in accordance with its deviation from the Lowest Bid Price (the "**Price Score**"), which can be also formulated as follows:

"**Price Bid**" = the summery of the Bid's Price as offered by a Bidder on **Annex 3**.

The successful Bidder

- (a) The Bidder whose Bid receives the highest aggregate score (Quality Score + Price Score) shall be declared by the Company as the successful Bidder in the Tender. The Company may select a Bid that does not have the highest aggregate score, due to special circumstances and for reasons that will be registered.
- (b) In the event that two or more Bids received the same total score, the winner of the Tender shall determine from among these Bids in the following order: (A) In the event that one of the above Bids is a business controlled by a woman and the circumstances and conditions stated in section 2B of the Tender Obligation Law, 5752-1992 were met - the winner of the Tender will be the same business controlled by a woman; (B) In the event that the above paragraph A is not met, the Company may make its decision as to which Bid is preferable based on its discretion while preferring the Bidder which achieved the better Quality score.

6.2. Post Qualification & Award

- a) The Company reserves the right to waive any formality and to cancel the Invitation to Bid at any time or not to accept any of the Bids or to award the Contract to the Bidder whose Bid gives most advantages to the Company even if it is not the lowest price offer among the Bids.

- b) All the Tender Documents including all clarifications and amendments issued by the Company during the Tender shall apply as an integral part of the Agreement.
- c) No Contract shall come into force before the Company signs the Contract by its authorized signatories.
- d) If the successful Bidder does not comply with any of its obligations according to the Tender Documents within the designated period, for any reason whatsoever, the Company shall be entitled, to cancel the announcement of the Bidder as successful Bidder and select another Bidder as a successful Bidder, without derogating of any its rights under the Tender.

6.3. Negotiations with Bidder/s

Subject to applicable law, the Company at its sole and absolute discretion, will be entitled to conduct negotiations with the Bidders whose Bids founded by the Company compatible for negotiation, in the number of Bidders as determines by the Company, in any way the Company deems suitable and in any of the stages as set forth in section 5.1 above, including but not limited to negotiate simultaneously with more than one of the Bidders, and/or to allow any compatible bidder to submit a renewed or rectified Bid including its best and final Bid, and to cease such negotiations at any time. The Company reserves the right to reinstate any Bidder at any stage of the process subject to the agreement of such Bidder, and subject to such Bidder's compliance with all requirements and criteria set for such stage.

6.4. Confidentiality

By submitting the Bid, the Bidder undertakes to keep in confident all kind of information and data relates, directly or indirectly, to the Company which the Bidder may get or to be exposed to subsequent its participation in this ITB. The Bidder undertakes to take all required measures to insure this obligation is kept by everyone on its behalf in respect to this ITB. All the Bidder's team members shall sign the Non-Disclosure Agreement in the form provided in **Annex 7**.

6.5. Right to Review

- a) Up to 30 days following the announcement of the successful Bidder a Bidder shall be entitled to review the Company's decisions and the successful Bidder's Bids, and to receive a copy thereof, all subject to and in accordance with all relevant laws and regulations. The foregoing review shall be for a fee of NIS 500, including VAT.
- b) Bidders shall not be entitled to review the successful Bidder's Bids until the Company decides which parts thereof are commercially sensitive or confidential under any Law, and as such, shall not be disclosed. The procedure (including the time schedule), with respect to disclosure of documents and review by other Bidders shall be determined solely by the Company.

- c) The Company shall evaluate the commercially sensitive or confidential nature of parts of the successful Bidder's Bids to the extent they were identified as such by the successful Bidder. Bidders shall not be entitled to argue that the Bid, other than those parts identified by such as being of a commercially sensitive or confidential nature, cannot be reviewed by other Bidders and each Bidder shall be deemed to have waived any claims it may have with respect thereto. Bidders shall not be entitled to review those parts of the successful Bidders' Bids, which have been identified by themselves to be of a commercially sensitive or confidential nature (in their own Bid), unless otherwise permitted by the Company.

1. Part 1 - Zohar Field Reservoir Report analysis and recommendations and Three-dimensional geological modelling

A. The Services shall include the following:

- 1.1. Review and analysis of the existing RPS Report on the Zohar Field and deeper structures (Sherif, et al), discussion of the basic assumptions of the report and conclusions and submitting a validated report on the reservoir’s potential for UGS.
