Q-1	ITB, Clause,	Is the Bidder required to have experience on Engineering and Design itself rather than Design Review experience.
A-1	12.2.3. Bidder's Professional Experience	Yes. The Bidder must hold at least fifteen (15) years' experience in providing engineering, design, supervision, and consultancy services for the design, construction and operation of high-pressure Natural Gas transmission systems.
Q-2		The Bidder published accounts are not in Euro currency. Would 'Turnover' converted into EUR be acceptable?
A-2	ITB, Clause 13.4.11. Bidder's Financial Strength	Please refer to the footnote of the clause 13.4.11: "Financial information denominated in currencies other than Euro shall be converted by the Company into Euro, based on the exchange rates published by the Bank of Israel in the last date for submission of Bids (or any other reputable Bank as determined)."  The "Company" in this case refers to "Israel Natural Gas Lines Company Itd".  The bidder shall submit the financial information as per the Bidder's account currency. The conversion shall be done by INGL.  Accordingly, in ANNEX A11 - BIDDER'S FINANCIAL STRENGTH, the Bidder may add to clause 2, an option of the local currency (besides NIS and Euro).
